

SUMMARY ANNUAL REPORT FOR

This is a summary of the annual report of the 24 7.AI HEALTH AND WELFARE BENEFIT PLANS, a health, life insurance, vision, temporary disability, long-term disability and death benefits plan (Employer Identification Number 94-3359939, Plan Number 501), for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has insurance contracts with KAISER FOUNDATION HEALTH PLAN INC, VISION SERVICE PLAN, CONCERN EAP, NATIONAL UNION FIRE INSURANCE COMPANY OF PITTSBURGH, PA and LIFE INSURANCE COMPANY OF NORTH AMERICA to pay certain Health, Prescription drug, HMO contract, Vision, Employee Assistance Program, Employee Assistance Program, Life insurance, Temporary disability, Long-term disability, AD&D claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$848,973.
